Companion Placement: After an online application, our heroes are assigned trained adoption counselors to help them find the right rescue animal for their lifestyles and needs. Working with heroes, local shelters, and rescues, C4H adoption counselors guide the heroes through the adoption process, striving to make sure that the personality and temperament of the dogs will closely match that of the heroes to ensure the success of the adoption. Following the adoption, C4H reimburses the heroes for their shelter and/or rescue fees, provides gift cards for intial pet supplies, and provides free training when required for the heroes' animals.
